The councils/districts sending winners to the Regional contest **MUST** submit a list of their council winners with ages to the Regional Chairman in advance. Those winning entry forms & BC copies must be delivered by the council/DD chairman to the Regional chairman in advance of the regional contest.

Councils must have held a council level competition to have their winners advance to the further competitions.
